Granite Goose draft Environmental Assessment (EA)

The draft EA has been posted to the [project's webpage](#) for comment. If you have issues viewing it there, you can access the document [here](#). The comment period closes February 3.

PFC-related project documents are housed on the Coalition's website in the [Project Library](#). To see the Coalition's recommendations, (applicable to all projects within the former Granite Meadows landscape), select "Granite Meadows" in the drop-down menu of projects, and click "Search." The recommendation document is dated 8/22/22. The PFC's scoping comment letter and associated documents can be viewed by selecting "Granite Goose" in the drop-down menu and clicking "Search." There are two other documents here as well which can help members focus their consideration of the draft EA: 1) [Forest Service review of PFC recommendations](#) which shows how Coalition's recommendations and scoping comments were addressed in the draft EA, and 2) PFC mission, goals, and objectives.

The PFC's objective will be to decide by consensus whether to submit a letter of support and/or comments. The voting threshold will be a consensus of eligible voting members present minus one. Eligible members are those who voted on this project's recommendations. To use our time efficiently, members are urged to review all documents before the meeting and come prepared to discuss. There is a discussion thread on the [PFC Forum](#) (Granite Goose Environmental Assessment) where members can begin discussions before the meeting.
